2. Approval of Agenda and Minutes

3. Municipal Election - Monday October 22, 2018

- The OCDSB has a policy on election activities that covers school councils. See P.122.GOV
 - (https://weblink.ocdsb.ca/WebLink/0/edoc/3054208/P%20122%20GOV%20-%20Election%20Activities.pdf). If councils have questions, approach board staff or OCASC chairs.
- If a school council chooses to endorse a candidate, then the council must hold a vote and document it.
- If a Trustee candidate is invited to a council meeting, then all Trustee candidates must be invited. Trustee candidates must be given equal time to speak. Candidates can decline to attend and that is ok.
- Zone 8 Candidate Meeting: Tuesday October 9 at 6:30pm at Maple Ridge Elementary.
- School council members may endorse a candidate personally, but not as a representative of a school council.

4. Council Banking Update - Update from the OCASC Council Banking Working Group (Christine Moulaison)

Objective: To enhance and ensure compliance with Ministry guidelines including but not restricted to:

- accountability
- finance reporting
- transparency
- to strengthen implementation of already existing OCDSB policies. Note: All of policies and procedures already in place would have prevented issues that have arisen in the past (if they were enforced).

Some suggestions and ideas from OCASC Working Group:

- A new OCASC Executive member is voted in as a Council Banking Head/liaison to the OCDSB for any council banking issues/inquiries.
- Audits can be done by OCDSB/OCASC executive members alike and/or together as a team.
- Expand current end of year reporting spreadsheets to include more detailed information and have them live, online, for easy completion, submission, and collation for OCDSB staff and OCASC members alike. OCASC is more than willing to provide

members to aid any councils that reach out for help in completing and submitting said forms.

- Have these reports be completed twice yearly to help ensure compliance by all members.
- Begin with a a pilot project that starts with a few schools the first year, we can then
 expand to all OCASC member schools the following year. Once all parties are
 satisfied that the project is working and is beneficial to all parties, we can expand to
 all schools in the OCDSB.
- Hold two evening talks, one east and one west, to provide as many councils as
 possible with information on the new reporting program as well as ways to help keep
 proper records to help adhere to ministry and OCDSB guidelines for all councils.
- Create a simple and user friendly spreadsheet to new and/or smaller councils to help simplify and keep detailed records as per ministry and OCDSB guidelines.
- Have council Chair, Treasurer, as well as school Principal/Vice Principal sign off on all reports provided to board to ensure that both parent and board staff members alike agree that all the information is correct to the best of all signatory members memories.
- Increase parent engagement with councils. The more parent members we have, the more people we have monitoring the financial records.

OCASC long term goals:

Begin a mentorship program between schools within wards, as needed, to aid in building strong, involved and inclusive school councils as well as helping increase those schools fundraising ideas and goals.

Questions:

- The 'Council Banking Head/liaison to the OCDSB' position would be an OCASC executive position.
- Audit Committee Can OCASC have a spot on the audit committee?
- Suggestion for term limits for treasures. Any council can put that in their constitution.
 Might be difficult for small councils.
- Lots of money is handled by councils approximately \$8 million in transactions
- School Cash Online 3% administration fee on \$8 million is a lot of money

5. Truth and Reconciliation and Indigenous Curriculum - Tim O'Loan

- Worked for Senator Murray Sinclair as part of the Truth and Reconciliation Commission.
- Last residential council closed in 1996. Many policies are in effect related to Indigenous people that Canadians should not be proud of.
- 94 calls to action from TRC
- TRC recommended changes to public education curriculum. Requires adequate funding.
- If change is going to happen, needs to happy with children.

 - A lot of information on Mamawi Together web page.
- Can provide assistance and connect councils with elders
- New books are available for librarians on reconciliation and indigenous issues. School councils may want to fund these books.
- The book 'They Came for the Children: Canada, Aboriginal Peoples, and Residential Schools` is a good foundation book.

10. SEAC (Special Education Advisory Committee) Update

- Legislated committee. Provide advice to the board on special education.
- Approximately 2 years ago as a result of the Gifted Program Review, a Gifted Advisory Group was formed "to expand options to be presented to the public to improve the effectiveness of services for gifted students and to increase equity of access for under-represented groups".
- Drop in enrollment in gifted specialized classes was due to implementation of Tiered Intervention, but this was not widely communicated. As a result the there are no children in the grades 1 and 2 of the gifted specialized program. There are 4 students in grade 3 and 6 in grade 4.
- Complaint Letter was written by non-staff members with concerns about the gifted advisory group. The letter was distributed. Dana our OCASC SEAC representative was one of the 4 members who wrote the letter.
- Decisions on special education programs also impact children in the regular classrooms, as more students with special education needs are integrated into the regular classroom.
- Trustee Boothby has put forward a motion on the gifted program.
- The complaint letter regarding the Gifted Advisory Group and Trustee Bootby's motion will both be discussed at the October 10th SEAC meeting and the October 16th COW meeting.
