2. From your executive (including COW, SEAC, PIC, and EDP Committee Updates)

Christine (South March/Co-chair) School has asked whether councils have support in place for major family emergencies. Multiple situations have come up at one school. Question – whether councils have done anything to support.

Family where mother passed away. School created Meal train – to support with food, food from red apron, membership to museum of civ and money came out of School council

Martyn (Stittsville PS) – Parent injured in bus crash, council sent a roster of meals

(Get chat – good suggestions)

Parent Involvement Committee: (Malaka): Last meeting of PIC is always well before the budget release. Work plan was adopted at the last meeting. Will post on OCASC Facebook page. How will councils get informed by the discussions at PIC, one key topic of interest is the de-streaming of math.

Topic council budget report, delegates raised issues about information being misleading about council budgets. The report misrepresents the holdings of schools. Finance staff is not interested in correcting it or adding context or additional information.

Comment: OCASC could provide a report that would counter- balance the report that has been released.

Comment: Financial reports are provided to the board that include a lot of detail. They are provided to the board every year that include what money is raised for and what it is spent on. Some schools have capital holdings for a play structure or other large item over years.

Issue: Is that board can point to inequity to justify banning fundraising. OCASC could also request a change to the most common budget categories, which aren't represented properly on the existing budget templates.

Comment: If the information in the report is incorrect about the balance for your school, if the report goes to COW, there is an opportunity for parents to delegate to speak to that report.

Committee of the Whole Christine (South March/Co-Chair): Letter for boundary review, COW merged with Board meeting for a special meeting. One school has 55 students, single track school. Parents trying to bring EFI into the school to broaden the school. Devonshire close by is over capacity in EFI. Trustee was involved. Boundary reviews have been on hold with the Province for 6years. Christine is requesting if OCASC wants to make a motion for OCASC to send a letter to request a review of the moratorium. Cambridge is the school.

Comment: This school serves very vulnerable populations. Serves a whole community, the school impacts the whole community. Request to share the article from the Citizen. Juliet Knapton (OCV) will look for it.

Comment: The virtual schools may have an impact on classroom crowding.

Comment: Board is currently reviewing school zones according to the new city zones. Boundary review and accommodation review are different and have different triggers.

Comment: Justine Bell is Trustee. She has had a challenge to move the review forward.

Question Would letter be from individuals or as school rep.? Motion would be for a group to draft a letter. Juliet volunteers to be a part of the drafting committee.

MOTION: We will undertake advocacy as a group which may take a variety of forms eg. letters/social media to address the moratorium on boundary reviews.

Motion: (Glebe), Second (Henry Larsen), passed with unanimous consent.

Comment: Recommend 2 fold, letter, and also OCASC fb page or twitter to comment publicly. To allow voices to be heard.

Grants for student needs have come out. Budget process will start June 1st. Meeting will be public. OCASC is invited to sit at the table. OCASC can have a special meeting to discuss.

Mental health is a priority, delegations have spoken to COW re. mental health. 2019 1.6% of the board budget, 2020-21 board stayed with 1.6%. This year the Province has said that they will give more money for mental health. This means that services could run over the summer. It's a

Now is the time to advocate for spending if we think its important. Do we want a special purpose meeting to discuss any advocacy on these topics?
