### COW - Committee Of the Whole (Christine M)

- Motion to amend Policy
  - Christine acknowledged and thanked all councils and individuals that sent in letters and did amazing written and spoken delegations at COW. The support was greatly appreciated and reinforced the value of OCASC.
     All this helped keep OCASC's seat at COW.
  - There was a substitution motion placed on the floor by Trustee Scott to:
    - add a new PIC non-voting member to both COW and COW budget.
    - There will also be a moratorium placed to adding any more members and
    - a formal review of the committee membership policy, it's nonvoting committee members, their roles and responsibilities, and a potential change to those non-voting members will be asked to be completed by staff.
  - No timeline was set out for this work to begin or to be completed by.
  - o OCASC seat remains unchanged

# SEAC (Special Education Advisory Committee) - Safina

- De-streaming
  - Destreaming has been presented very positively yet there are some concerns about the negative impacts de-streaming were presented by Dr. Maggie Mammon and points from meeting:



- Lack of differentiated learning is difficult on all students as all learning needs takes effort to accommodations and support
- The teaching methods are critical for its success and there is large fear that teachers are not properly trained or supported through this and it has big impact on students
- Classroom size, de-streaming is best with smaller class sizes which are not present currently
- The rush in which new Math in grade 9 and 10 has been introduced is concerning. Ministry had not provided destreaming curriculum and at OCDSB be academic math is being taught.
- Concerns at how OCDSB will be supporting the implementation of ministry mandated destreaming in math, but in future other subjects.
- o Learning Support Services will return to committee with more information
- Malaka reinforced councils role in student achievement and well-being. Councils can ask Principals to share what this means students now and 5 years from now as de-streaming continues and is expanded. Can ask how school is being supported and what changes are being made. Asking the questions bring up needs and what each school requires for supporting student achievement and well-being.
- PPM 81 Policy review on Speech Therapy which looks to streamline the
  process of receiving support. Currently there are two separate processes 1.
  OCDSB process and 2. Outside Agency or Community organization. They are
  not the same and therefore students and family experience varies widely. SEAV
  should put forth request to simplify this process.
- Covid update increases in cases at schools and one school is closed but no current plans for school closures.

- Invites all councils to appoint an ARTS REP on each council. They can represent
  the ARTS at their school with support of Arts Advisory Committee. Parent does
  not need to be an artist, musician, actor, dancer. It is great if person has passion

# **DISCUSSION and NEW BUSINESS**

## Parent Reaching Out Grants (PRO)

Ontario's Parents Reaching Out (PRO) Grants are designed to support parents in identifying barriers to engagement in their own community and to find local solutions to involve more parents in support of student achievement and well-being

- Annette Dillion and Malaka Handela are PIC's PRO Grant subcommittee provided history and context.
  - Up until two years ago, PRO grant changed from individual schools applying for funds it now goes that BOARDS now get the PRO grant money and manage it as needed.
  - o Last year PRO grant OCDSB was spent on Speaker Series councils could sign up for. List provided by board with speaker options or to arrange own speaker. Report from last year has not been received, so not sure what the uptake was last year. Did get feedback that councils were burnt out with respect to speakers and that the process was a confusion and inconsistent.
  - OCDSB PIC has \$78 000 to spend on Parent Engagement. It can spend that in what every way it decides. Could be all in one lump sum or as individual amounts.
  - o PRO Grant funds must be spent by June 30, 2021

- They PIC are seeking input and suggestions. What to do with \$78 000? Contact Annette
  - SUMMARY three options:
    - 1. Pers school allocation
    - 2. Parent / Council Day or Conference many topics such as council training and parent interest, and definitely training on Virtual presence
    - **3.** A substantive thing communication materials, community art project, parent engagement booklet, language translation
  - Erika money should go back to the schools, as it's been difficult to fundraise. In addition, please also provide comprehensive and simple



instructions and parameters. Malaka clarified that PRO funds need to be directed to Parent Engagement, there is also yearly councils support funds of \$500 that has no limitation of how councils spend it.

- Canterbury HS Susan B.
  - Feedback from last year's process was very uncomfortable, felt rushed, very competitive and stressful.
  - The lateness is getting information made it difficult to plan. The options given by OCDSB were not of interested to her school community and thought they tried to get a different speaker/activity, were very disappointed at not being able to find anyone in time and thus did not get benefit of this PRO Grant
  - School community was "speaker"ed out, had little capacity at this time to attend or coordinate anything
  - Many at meeting has similar experience and agreed that the process was not one they want to have repeated
  - Need clarity as the purpose of the grant what is it PRO actually for? To keep that as the prime focus.
- Ridgemont HS Nancy D
  - Please bring back Parent and School Council conference and provide virtually.
  - How can councils reach more parents, supporting that, language translation, communication tools, parent volunteers – support on coordination best practices
  - Council and school admin/staff collaborations
  - Community art projects to allow for connection again
  - Training on currently provided supports by the board, ie. Website, google account
- Meaghan prefers to have central organization and coordination
  - No more speakers
  - Help councils with VIRTUAL presence. Tech training on websites, page, social media, email
- Safina wants a council community day. Concerned with timing and does not want \$ to lapse. Wants OCDSB to do something soon.
