- Two delegations. First from someone wanting to keep mask mandates in place, but that's moot...and you can probably add more from the special meeting on that point that you attended.



- Second delegation, David Aden, discussed diversity and inclusion in public schools; in particular staffing, noting he had a friend/associate who was qualified to be a principal but opted to start his own online school. Trustee Scott had some clarifying points, and Trustees Fisher and Hough said they wanted to work with Aden and his group on the matter.
- Consultation Plan for New Policy P. 144.SCO Student Exclusions. Policy mentioned consulting with school councils but did not mention OCASC, even though SEAC, ACE and IEC were mentioned. Trustee Lyra advocated for the inclusion of OCASC, but group decided to just exclude councils altogether. There was a suggestion that info could go out in a newsletter. I spoke to the point, noting that we should be consulted regardless of whether councils were consulted directly mentioning that we're still the more appropriate conduit to get the message out to councils.
